**Please read all disclaimers**

-  The Parade Chairman reserves the right to reject ANY parade entry at ANY time for ANY reason, including, but not limited to: intoxication, late check-in, disruptive or inappropriate behavior and/or undecorated entry.
-  **An individual can not participate unless he or she has signed a release form.**
-  Application must be complete including length of entry. Incomplete applications will be rejected.
-  Should an entry need to drop out, you must contact the Chamber by **December 2nd**. Entries dropping out after this date or failing to show on the day of the parade will not receive a refund of entry fee.
-  **You must specify on the application if your entry has ANY walkers.**
-  The Parade officials have made arrangements for **ONE SANTA** to be in the parade (this is to eliminate confusion for the children).
-  All entries must have a definite holiday theme.
-  If the parade cannot be held on Monday, December 9th, due to rain or snow, it will be held on Tuesday, December 10th at 6:30 pm if possible. There will be no refunds given should the parade date change. We appreciate your understanding that these kinds of situations are beyond our control.
-  **Cut off on scheduled parade day is at 3:00 pm for possible cancellation due to weather.**

**Christmas Parade**  
**\*\* Safety Alert\*\***

**This announcement is for all that are driving, riding, or walking in the Christmas Parade**

To ensure the safety of everyone that attends or participates in the parade the following will be enforced with no exceptions.

- 1) If you are driving in the parade, except antique cars, the parade route starts and ends at the Saddle Club.
- 2) The antique cars will line up at A&R Body Shop. They will follow the parade route back to the Saddle Club but they do not have to enter the parking area. They may continue on to a turnaround spot or continue.
- 3) Adults and children walking in the parade will end at Southgate Shopping Center.
- 4) Anyone that breaks line by pulling out of the parade before completion may be ticketed by the police.

The ones walking are particularly vulnerable when others pull out of line and cause gaps in the parade. This allows non parade participants to mingle with the parade and may not be tolerant of slow speed of the parade.

If there is a reason that your float or vehicle cannot complete the route an exception **MUST** be approved by the Chatsworth Police Department.

LIST OF RULES

**LINE UP 4:00 pm- 6:00 pm @ the Murray Co. Saddle Club**

- 1) All walkers & Band members line up at First National Community Bank parking lot.
- 2) No throwing of candy – candy handed out by walkers only.  
**\*\*If the police or rescue squad observes anyone on your float throwing candy, driving dangerously or too fast, your organization will be banned from future parades.**  
**\*\*Please do not get our children injured!!**
- 3) All floats must be decorated & in line by 6:00 pm.
- 4) All riders need to be on your float by 6:00 at the latest.
- 5) Walkers/Walking Groups are to be dropped off at the First National Community Bank parking lot and be in line by 6pm.
- 6) Your float must be hooked once it reaches the Saddle Club (You will not be able to unhook and leave your trailer without a tractor or pull truck.)
- 7) Be sure your entry has fuel before lining up for the parade!
- 8) Do not drop riders off at end of parade; keep on float at all times!
- 9) Breakup at the Saddle Club after the parade.
- 10) All trash must be picked up before you leave your area.

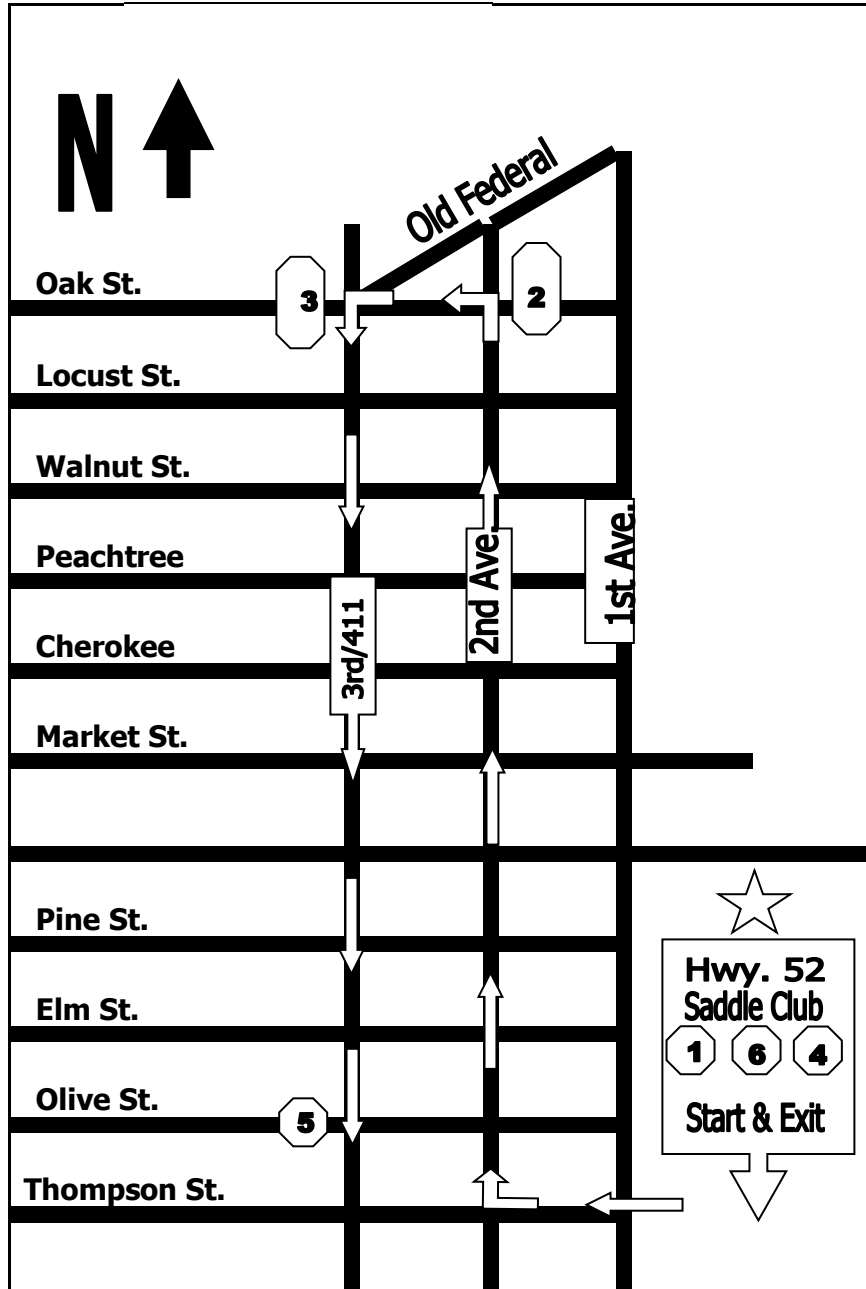

## Parade Line up & Route

The only entrance to 2nd Avenue is from Highway 52, all side roads will be closed for drop off & pick ups. Do not park in front of any driveway on the side streets. Additional parking for participants is in the City Hall parking lot beside El Pueblito on 2<sup>nd</sup> Ave.

**Notice that all riders of floats must stay on their float until it arrives back at its original lineup spot.**

Remember, this parade is at night & every precaution should be taken to prevent accidents.



**IF YOU NEED ASSISTANCE,  
PLEASE SEE PARADE OFFICIALS  
WEARING ORANGE VESTS.**

1. **FLOATS** are to enter from **The Saddle Club** (560 Highway 52 East Chatsworth, GA 30705). You will be assigned a number at **the Saddle Club** which will be open at 4:00 pm. Floats need to be in your numbered line-up space by 6:00pm.
2. A & R Body Shop will be reserved for **DIGNITARIES AND ANTIQUE CARS**.
3. **WALKING GROUPS** are to be dropped off at the First National Community Bank drive thru and be in line 6pm.
4. **HORSES** are to check in and lineup at **the Saddle Club**.
5. **WALKING GROUPS** are to EXIT the parade at Olive Street and enter the Southgate Shopping Center parking lot for pick-up.
6. **ALL ENTRANTS** please refer to safety alert instructions. **NO exceptions will be made.**

**NO ONE IS TO GET OFF THEIR FLOAT UNTIL IT REACHES THEIR ORIGINAL LINE-UP SPOT.**
